In addition to successfully defending countless high profile cases in federal and state court, Bruce combined with Gordon Graham to found Lexipol and continues to serve as Chairman of the Board. He also serves on several POST committees and teaches courses in Officer Involved Shootings, K9 Liability, Internal Affairs and the Executive Development Course.

**Michael Gennaco** – Principal, OIR Group. Mr. Gennaco is a lawyer who has specialized in the civilian oversight of law enforcement for fourteen years. Beginning in 2001, he was the Chief Attorney for the L.A. County Office of Independent Review, which monitored the L.A. Sheriff's Department. Mr. Gennaco also served for over six years as an Assistant United States Attorney for the Central District of California. More recently, Mr. Gennaco has also provided advice in oversight to police agencies throughout California, as well as Portland, Denver, and New York City.

**Stephen J. Connolly** – Executive Director, Orange County Office of Independent Review. Mr. Connolly has been a police monitor for most of his fifteen year career as an attorney. He has worked with the Sheriff's Departments in Los Angeles, San Diego, and Orange Counties in reviewing individual cases as well as broader systemic and policy issues, and has also been involved in shorter term projects in cities such as Burbank, Palo Alto, and Anaheim. Mr. Connolly provides training on supervision and risk management on a regular basis, and has spoken about civilian oversight at several national conferences.
