He has tried murder cases in superior court resulting in multiple first-degree convictions and has extensive experience questioning wrongdoers, victims of violent crimes, as well as witnesses. Kevin also has experience litigating forensic mental health issues, including dangerousness to the public, sexually violent predator (SVP) status, incompetency to trial (IST), mentally disordered

offender (MDO) status, and mental state during the commission of a criminal offense.
