**TACTICAL RIFLE  
24-HOUR COURSE**

**DESCRIPTION :** In this 24-hour basic Patrol Rifle Class, we introduce the shooter to their patrol rifle. Topics covered are; history of the AR-15/M-16 rifle platform, department policy, case law, force options, updated legislative content on the use of force and PC 835(a), weapon nomenclature, field strip & maintenance, weapon safety, ballistics & zeroing, marksmanship fundamentals, positional shooting, malfunction procedures and drills, weapon manipulation, weapon transitions, low light and night time shooting, and various tactical considerations. Students are required to demonstrate proficiency by participating in multiple fast paced and competitive drills, qualification courses, and shooting scenarios.

**MANDATORY RIFLE EQUIPMENT :** Students must bring a rifle that is approved for use by their agency. Rifle must be equipped and outfitted in accordance with agency policy (**NO bullet button or fixed magazine California legal rifles**). The minimum requirement for any outside agency is a sling, spare magazines with magazine carry pouch, and cleaning/maintenance equipment. Attached lighting device is recommended for nighttime shooting. For *VCSO students*, the rifle must be a department issued weapon or conform to VCSO Policy 306.

**Outside agency** ammo requirement is 1000 rounds of rifle & 100 rounds of handgun ammo.

**REQUIRED ADDITIONAL EQUIPMENT :** Duty handgun, patrol duty belt, tinted and clear safety glasses, and patrol ballistic vest. Gas mask, ballistic helmet, and rifle rated plate carriers are also required, if issued by your agency. Appropriate range attire required. **NO shorts, tank tops or sandals**. This course is demanding and requires moderate physical activity. Optional equipment are elbow pads, kneepads, water, and sunscreen.
