He was the president of CNOA in 2009 and is a Lifetime Member, and currently sits on their Executive Board. He also graduated from the FBI National Academy, Session 209. He was appointed to the CA Commission on POST by Governor Arnold Schwarzenegger. He holds a bachelor's degree in Criminal Justice from California State University, Sacramento.
