Immediate action must be taken to preserve life, by those already at the scene.

Based on the current guidelines of the Committee for Tactical Emergency Casualty Care (C-TECC), this NAEMT & CA POST certified provider course will give you the knowledge, the skills, and the confidence to save your life, or the life of another, during an active trauma emergency.

- **Rapid MARCH trauma assessment**
- **Individual and Mass Casualty Incident response, triage, and rapid care of critical penetrating, blunt, burn, and blast trauma**
- **Emergency moves and rescues**
- **Care for traumatic hypothermia and shock**
- **Tourniquets**
- **Hemostatics**
- **Pressure Bandages**
- **Occlusive Chest Seals**
- **Nasopharyngeal Airways**
- **Bag Valve Mask Ventilation**
- **Narcan**
- **Pulmonary management**
- **Prolonged care concepts**
- **Heat management**

These skills were incorporated into CA CCR Title 22 as mandated standard scope of practice for CA Law Enforcement in 2015. This comprehensive course provides an understanding of physiology, injury mechanics, and treatment protocols for traumatic injuries, through in-depth lecture and hands-on practice, drills, and scenarios. You will learn advanced treatment skills, why and how they are effective, what equipment is necessary, and why these skills are critical for everyone currently working in law enforcement, emergency response, and public services.
