COURSE DESCRIPTION

The course is aimed at helping law enforcement personnel in detecting, seizing, and prosecuting illegal indoor/outdoor marijuana cultivations and butane honey oil labs. It will cover a detailed approach to safely investigating marijuana-related crimes, from the initial investigation to writing the search warrant, dismantling the cultivations, identifying hazards and safety measures, conducting financial investigations, and gathering evidence needed for successful prosecution.
