She began her career with the San Bernardino County District Attorney's Office in March 2016, having been a volunteer deputy district attorney since September 2015. Her assignments have included misdemeanors, general felonies, gangs, and homicide. She has previously been assigned to specialty units, including SANCATT and Narcotics. Allison has completed 47 criminal trials, including rape, assaults, "three-striker" cases, attempted murder, offenses with gang allegations, and homicide. She has taught for the San Bernardino County Sheriff's Department Basic Academy, the California Narcotic Officers' Association, the San Bernardino County Sheriff's Department, and the San Bernardino County District Attorney New Prosecutor Training.
