## Confidential Informant Development and Management

**Description:** This class provides a comprehensive overview of confidential informant development and management. Students will learn how to analyze and evaluate potential confidential informants for use in specific types of cases. They will learn how to approach and manage the risks associated with informants and the legal requirements as well as ethical considerations.

Students will study real-world case examples of how confidential informants have been used in law enforcement operations. They will explore the successes and pitfalls encountered when using informants, as well as the techniques and strategies that proved to be effective in different situations. Students will analyze and evaluate these case studies and learn how to apply the lessons learned. Through an in-depth exploration of actual cases, students will gain a deeper understanding of how to effectively use informants in law enforcement and will develop the critical thinking skills necessary to assess the risks and benefits of different approaches.

By the end of the class, students will have a comprehensive understanding of confidential informant development and management, as well as the practical experience needed to use these skills in the field. They will be equipped with the knowledge and skills necessary to analyze and evaluate potential informants and manage confidential informant operations effectively and ethically. Whether students are new or experienced LE professionals looking to improve their skills, this class will provide valuable insights and practical tools for working with confidential informants in a variety of law enforcement contexts.
