- Identify the indicators to Tren de Aragua affiliation and use these indicators to document TDA membership and activities.

This course is appropriate for all members of the law enforcement community including patrol officers, detectives, correctional officers, parole officials, probation officers, DA investigators, prosecutors, and criminal analysts.
