Surviving Wall Stops and Protecting Confidential Information

Course Description:

The class will cover legal issues relating to the use of confidential information during criminal investigations. The focus will be on Informant concerns and Wall issues. The class will cover "Brady" discovery obligations, wire issues, wall stop issues, "Hot Roll" problems and courtroom survival using Evidence Code 1040.

The instruction will include a discussion on the legal tools that can be utilized during traffic stops to help protect your investigation.

Tom Manning has been a prosecutor for the past 30 years with the San Diego County District Attorney's Office. DDA Manning's experience includes assignments in the Felony Trial Unit, the Major Narcotics Unit, the Cartel Homicide Task Force, the Drug and Gang Task Force (JUDGE UNIT Vista), the Gang Unit and six years as the Chief of the Major Narcotics Unit. He is currently the team leader of the Cold Case Homicide Unit.

Tom was the first County DEC coordinator and is a past state chair for the Drug Endangered Children's Program. He has also served as a tri-chair for the San Diego County Methamphetamine Strike Force.

He is a regular instructor for CNOA, CDAA, the DEA Basic Narcotic Investigator School, the California Gang Investigators Association and ICI training programs. He is a POST certified instructor. Tom was the CNOA Region IV prosecutor of the year in 2000 and the San Diego County prosecutor of the year in 2009.
